RELEASE OF LIABILITY AND ASSUMPTION OF RISK - READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the Missouri Winter Games and/or its related events and activities, I, _____, the undersigned, acknowledge and agree that:
